IT IS HEREBY RESOLVED by the Township Council of the Township of Brick, in accordance with NJSA 54:4-67, to permit the fixing of the interest to be charged on taxes and assessments at 8% per annum on the first \$1,500.00 and allows 18% on any amount in excess of \$1,500.00 to be calculated from statutory due date until actual payment. Additional penalty of 6% to be collected against a delinquency in excess of \$10,000.00 on properties that remain unpaid at the end of the 2017 calendar year. There will be allowed the maximum ten (10) day grace period on quarterly tax payments.

Be it further resolved that the statutory penalty on a tax sale redemption has been increased pursuant to NJSA 54:4-67 as follows:

- 1. 2% \$200.00 to \$4,999.00
- 2. 4% \$5,000.00 to \$9,999.00
- 3. 6% \$10,000.00 and over
