### **Authorize Reappointment of Tax Assessor**

Mayor Ducey explained the duties of the Tax Assessor's Office. He said the township currently has 32,500 taxable properties totaling more than \$10B of assessed value. He stated Irene Rafferty is dedicated to follow in the footsteps of her husband's profession and joined the tax assessor's office in December 2000. He provided a short history of Irene's background. He stated he is proud to appoint Irene Rafferty as Tax Assessor for a 4-year term.

### **Authorize Execution of Conditional Redeveloper's Agreements with M&M At Route 70, LLC., and HFZ Brick, LLC**

Mayor Ducey announced this is a historic night in Brick Township getting the Foodtown property underway. He said it is the number one question he gets. He stated this marks the end of a court fight between township officials and the property's redeveloper, M&M at Route 70. He gave a short history of the development of the Foodtown site. He said the goal is to build something that everyone in town can enjoy. He stated even better than a recreational facility, but a facility that is privately owned/privately operated which is not on the backs of the taxpayers for many years to come. He said 6.05 acres in the back will be a recreation area redeveloped by HFZ Brick and the front area will be redeveloped by M&M with associated type retail.

Councilman Fozman thanked the mayor for all his hard work, the business administrator and the attorney for making this happen.

President Halloran opened the public hearing on the Resolution.

Tony Matthews commented the Forge Pond area is a very sensitive area being the source of the Township's drinking water; he asked that the engineer's and boards look into what is going to be done to protect the drinking water.

Nan Coll, 18 Greenbriar Boulevard, commented the mayor's facts and hers differ completely.

Walt Campbell, 655 Mark Manor Drive, commented there are three vacant stores in Costco Plaza. He stated bottom line is that they have tried for years to get the site redeveloped. He expressed his disappointment with retail. He stated there are only 6 buildable acres out of 10 to use in the entire area and the rest is restricted.

Kristine Goski, 131 Port Road, asked about the proposed rec center and restaurants and how Route 70 traffic will be eased and who will pay for it she suggested it be paid for by the developer.

Mayor Ducey stated this will have to go through the board process where there are traffic engineers, etc. and the developers are responsible for the cost. He said there is a percentage split between the two developers.

Richard Gross, 29 Greenbriar Boulevard, commented he was on one of the boards when the town decided to buy the Foodtown property. He said the board was not happy with the idea. He thanked the mayor, business administrator and attorney for what they have done for the township.

George Scott, 16 Queen Ann Road, commented on how much the property has actually cost. He thinks the agreement with both parties is ludicrous. He had several questions on the resolution. He asked if there are any other costs involved that the township will be responsible for. He questioned the cost of the subdivision and is it a shared cost.

Kevin Starkey addressed each of George Scott's questions. He stated anything related to the project will be paid by the redevelopers and the township will keep control of the project.

Vic Fanelli, 24 Meadow Point Drive, asked if the facility will be available for the schools to become customers of it. He questioned if anyone has gone to the schools and asked what they need.

Mayor Ducey stated the one up north has many schools using it.

Rob Canfield asked where the rest of the deficit is coming from on the property.

Mayor Ducey explained that is already gone. He stated the only way to get more money for the property is to allow residential and he said that he refuses to do that.

Pete Tasca of HFZ Brick LLC gave a brief history of his background. He described what the recreation facility could house. He stated kids need a safe haven to go to. He explained he has done his research in Brick Township to see what is needed.

George Scott questioned why it took 6 years to build one of the facilities.

Pete stated there were a lot of environmental issues because of what was there previously. He commented the building he is talking about for Brick is pre-fab and could be put up in 4 days.

Walter Campbell expressed his concerns with retail pad sites and traffic issues.

Nan Coll commented there should have been more discussion on this resolution.

John Sluka commented Saddle River is a high end community and asked if they would be charging the same rates down here.

Pete said they would not be charging the same rates as in Saddle River. He believes they will have the volume of children at the prices they can afford.

Melanie Briggs commented the schools all have their own facilities.

President Halloran closed the public hearing on the Resolution.

**Recognize National Emergency Medical Services Week – May 21<sup>st</sup> – 27<sup>th</sup>**

President Halloran stated this resolution recognizes National Medical Emergency Services Week, which is May 21– 27 honoring the Township’s emergency medical services professionals, who serve a vital role in the community.

**Authorize Insertion of Chapter 159 – Distracted Driving Campaign Grant**

President Halloran stated this resolution inserts a grant in the amount of \$5,500.00 from the New Jersey Division of Highway Traffic Safety for the Distracted Driving Campaign managed by the Township Police Department.

**Authorize Insertion of Chapter 159 – Bulletproof Vest Partnership Grant – 2015**

President Halloran stated this resolution inserts a grant in the amount of \$21,887.25 from the Department of Justice for the Bulletproof Vest Partnership program.

**Authorize Application – Recycling Tonnage Grant – 2016**

President Halloran stated this resolution authorizes the Township to apply to the New Jersey Department of Environmental Protection to assist the efforts undertaken by the Township to promote recycling. He said any grant funds received from this program are deposited into a dedicated recycling trust fund and will be used solely for the purposes of recycling.

**Authorize Application - Recreational Opportunities for Individuals with Disabilities Grant**

President Halloran stated this resolution approves the Township’s application for a \$16,000.00 grant to continue to develop recreation programs that provide inclusionary recreational opportunities for individuals with developmental disabilities between the ages of 11 through 21.

**Authorize Cancellation of Improvement Authorization Balances**

President Halloran stated this resolution authorizes cancellation of improvement authorization balances from 2005, specifically \$190,505.14 from ordinance 1152-05 which provided for the acquisition of certain parcels of land at Traders Cove, Hulse Tract and Bill Frank Tract. He advised this resolution cancels the unexpended authorization in that ordinance.

**Authorize Award of Bid – Uniforms for Various Departments**

President Halloran stated this resolution authorizes bids to Dot Designing, Monroe Township, and Keyport Army and Navy, Brick, for uniforms for various departments. This award is for two years commencing on May 24, 2017 and ending on May 23, 2019. He said bid notices were mailed to 27 prospective bidders, three of which picked up bid packages and two bids were received. The bid includes several types of uniforms. He advised there is a tie for three items: Item #13 adult tank top, Item #20 baseball cap and Item #21 knit cap. A coin toss was performed to break the tie with the winning award for Item #13 to Dot Designing; Item #20 to Keyport Army and Navy; Item #21 to Dot Designing.

**Authorize Award of Contract – Playground Equipment for Hank Waltonowski Memorial Park through HGAC-Buy National Cooperative**

President Halloran stated this resolution authorizes an award of contract to BCI Burke Company for the purchase and delivery of playground equipment for the Hank Waltonowski Memorial Park project from the Houston-Galveston Area Council- Buy National Cooperative in the amount of

\$107,144.95.

**Authorize Award of Negotiated Bid - Ice Machine at Traders Cove Marina**

President Halloran stated this resolution authorizes an award of bid to Ice King and Cold Storage, Tinton Falls, for an ice machine at Traders Cove Marina. He advised there is no fee to the Township for the ice machine box with a price of \$2 for 10-pound bags of ice and \$4 for 20-pound bags.

**Authorize Change Order No. 2 Final – Firing Range, Site Work Only**

President Halloran stated this resolution authorizes a change order in the amount of \$6,781.55 to the contract awarded to Compass Construction for the firing range. He advised this change order is specific to site work needed to complete the project and includes repairing the extreme slope on the old berm side that experienced severe erosion this past spring as well as the cost to install additional concrete blocks to stabilize the berms at the main entrance and on the old range side to protect the inlet.

**Authorize Suspension of Noise Ordinance – Relay for Life at Brick Township High School**

President Halloran stated this resolution approves the suspension of the Township's noise ordinance for the American Cancer Society's Relay for Life at Brick High School on June 2<sup>nd</sup> and 3<sup>rd</sup>.

**Ordinance on First Reading: Amend Chapter 245 – Signs**

Clerk Iannarone read the title of the Ordinance into the record.

President Halloran explained back in 2009, the Township Council approved a stimulus sign ordinance with a sunset provision to allow businesses to display sandwich board signs. It was intended to help the small businesses. He said this was not past practice and was done as a result of the economic downturn. He said the stimulus sign ordinance allows for streamers four times a year, not just grand openings, and each year the Council's Land Use Committee reviews to determine if the provision is still needed. He advised the committee unanimously agreed that the ordinance be renewed to the end of 2018.

Motion by Vice President Zapcic and seconded by Councilwoman deJong to to adopt the following Ordinance on First Reading and said Ordinance be published as provided by law:

**AN ORDINANCE OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING THE TOWNSHIP CODE OF THE TOWNSHIP OF BRICK, SO AS TO AMEND CHAPTER 245, ENTITLED "LAND USE" TO AMEND VARIOUS SECTIONS OF ARTICLE XXXVI ENTITLED "SIGNS"**

**Ordinance on First Reading: Amend Chapter 245 – Land Use – Microbreweries**

Clerk Iannarone read the title of the Ordinance into the record.

President Halloran explained this ordinance amends Chapter 245 to allow microbreweries in the B-2, General Business Zone, the B-3, Highway Development Zone and the M-1 Light Industrial Zone. He advised there is no definition in the State law for microbreweries, so as part of the ordinance, the number for barrels that can be produced a year is outlined at not to exceed 15,000 barrels per year. He explained an entity that holds this license from the State for the smallest barrel production can apply but the township limiting the number of barrels to be produced annually so that it doesn't become a production/distribution site. He said with this ordinance change, a use variance is not required, but will still require site plan approval by the Planning Board. He said zoning, engineering, and construction permits would be required, which is standard for any new business alteration.

Motion by Councilwoman Crate and seconded by Councilman Mummolo to adopt the following Ordinance on First Reading and said Ordinance be published as provided by law:

**AN ORDINANCE OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING THE TOWNSHIP CODE OF THE TOWNSHIP OF BRICK, SO AS TO AMEND**

**CHAPTER 245, ENTITLED "LAND USE" TO PERMIT MICROBREWERIES IN THE B-2 GENERAL BUSINESS ZONE, THE B-3 HIGHWAY DEVELOPMENT ZONE AND THE M-1 LIGHT INDUSTRIAL ZONE**

President Halloran opened the public hearing portion of the meeting.

Anthony Matthews congratulated everyone for promoting Irene Raftery. He commented using the Costco site may not be a good comparison to use due to the history behind it. He spoke about lead in the water. He thinks it's important that people are aware if there is lead in the water.

Mayor Ducey answered the water issue.

Councilman Fozman agreed with the mayor.

John Sluka, 950 Sylvia Court, read his letter regarding the parkway construction project.

Vic Fanelli, 24 Meadow Point Road, spoke about the lawsuits in general terms.

Kevin Starkey responded typically it's the insurance carrier pays when it's alleged that the people have suffered some kind of injury at the town; that includes the township, elected officials and employees of the town as well. He stated we are insured through the Ocean County Joint Insurance Fund.

Rob Canfield asked a question as to who people are accountable to that are appointed by council to various boards, for example, commissioners on the Housing Authority.

Kevin Starkey responded on the housing authority the commissioners are appointed by council but that organization reports to the Federal Housing and Urban Development because the Federal Government provides significant funding. He stated other organizations are handled differently. He said the fire districts are an independent organization elected by the people so technically they are governed by the people who can vote in or out.

Cathy Erickson, 58 Collins Court, commented she was happy to see the West side of Exit 91 open and asked what the expected date of completion is for the East side. She asked about the Housing Authority and the person who was removed.

Mayor Ducey commented the last he was advised was Memorial Day weekend but that is in a couple of days so he believes July. Mayor Ducey stated none of the council knew the person had a criminal record when she was hired and none of the commissioners that hired her are on the board. He reported they are doing an audit.

Vic Fanelli, 24 Meadow Point Road, commented on an article about the Homestead Rebate that the money would not be available until July.

Rob Canfield, commented the executive director of the Housing Authority was not appointed by council and asked if the commissioners or executive director would have to undergo a background check or could that be implemented in the future to prevent this from happening at another time.

Kevin Starkey responded the commissioners of the Housing Authority run the Housing Authority. He said they determine the policies and procedures and they are reviewed by and report to the Federal Government.

There were no further comments from the audience.

President Halloran closed the public hearing portion of the meeting.

Joanne Bergin congratulated and thanked the EMTs who do a wonderful job. She congratulated Irene Raftery for doing a wonderful job and is honored and please the mayor has reappointed her. She congratulated the teachers of the year and a special thank you to the Teacher of the Year, Meredith, who also works for us all summer long as the assistant second in command with Donovan Brown with the lifeguards.

Mayor Ducey spoke about bail reform. He talked about the Memorial Day Parade and Ceremony.

Lynnette Iannarone congratulated Irene Raftery.

Councilman Mummolo congratulated all recipients, EMTs, Students of the Month, Irene Raftery, Troop 6 for leading them. He announced to all boaters that F-Cove will be open this year, please keep it clean and use the Ocean County Pump Out Boats. He said the Secret Garden Tour will be July 11.

Councilwoman deJong congratulated all who were honored and reappointed tonight. She announced a Dog Yappy Hour on June 9. She thanked all who worked on the Foodtown Redevelopment Site to resolve this lawsuit. She wished all a happy Memorial Day and to all of our veterans who have served.

Councilwoman Crate congratulated all who were honored this evening. She is very excited about the Recreation Center and is thrilled to be on council when they were able to get this done. She reminded everyone that the Farmer's Market is open.

Councilman Fozman thanked all the students and congratulated Irene Raftery. He is happy to see the Foodtown Site resolved. He spoke about recycling shopping bags. He talked about the MUA meeting this Thursday night and said if anyone had any questions just come to the meeting. He spoke about the programs at the PAL building.

Vice President Zapcic congratulated Irene Raftery. She thanked Mayor Ducey for recognizing and rewarding when we have highly competent staff members and putting them in the right position. She thanked the EMS for all their hard work on our behalf. She congratulated the teachers and support staff. She also mentioned Meredith Hudson's role as being a lifeguard and assistant beach captain and also said she is the artist who paints the windows over at Civic Plaza. She congratulated the Lake Riviera Middle School Technology Students. She wished all a happy Memorial Day and thanked all Veterans.

President Halloran thanked and congratulated all recipients from the EMTs, medical services and especially Captain Tim Boyle and Sgt. Neal Pederson, Director Rob Contreras and Deputy Director Michael Botts who lead these people and manage and guide them.
