

**TOWNSHIP OF BRICK**  
**NOTICE TO BIDDERS**

**A NOTICE IS HEREBY GIVEN** that sealed Bid Packets will be received by the **Purchasing Agent** for the **TOWNSHIP OF BRICK, COUNTY OF OCEAN**, State of New Jersey on **JULY 11, 2024** at **11:00 am** prevailing time at the **Township of Brick Town Hall, Council AB Room, 401 Chambers Bridge Road, Brick, NJ 08723** at which time and place the Bid Packets will be publicly unsealed and its contents announced in public for **ROAD IMPROVEMENTS TO CHERIE MANOR**.

The scope of Work contemplated for the abovenamed Project includes **concrete curb and driveway aprons, reconstruction of curb ramps, full reconstruction of pavement, and general surface restoration** as well as all other Work of any type or description necessary for completion of the Project, whether or not specifically described in these Contract Documents. All Work on this Contract shall be completed within **(60) Calendar Days from Notice to Proceed**.

Contract Documents may be examined and/or purchased at \$17.00 per set, Monday through Friday, except legal holidays, from 9:00 A.M. to 4:00 P.M., prevailing time, at the Office of the Purchasing and Contracting located at 401 Chambers Bridge Road, Brick, NJ 08723. Cash is accepted and all checks are to be made out to the "Township of Brick"

The provided Bid Packet must be completed in the manner designated in the Contract Documents, must be enclosed in a sealed envelope bearing the name and address of the Bidder and the name of the Project on the outside and must be addressed to **TOWNSHIP CLERK**. Also, Bid Packets must be accompanied by a Statement of Consent of Surety from a surety company holding a Certificate of Authorization to do business in the State of New Jersey and either a Bid Bond or a Certified Check drawn to the order of "**TOWNSHIP OF BRICK**" for not less than ten percent (10%) of the total bid price amount, except that the check shall not exceed \$20,000.00. The successful Bidder is hereby notified that a Performance and Payment Bonds for the full amount of this Project is required.

The award of the Contract for this Project will not be made until the necessary funds have been provided by **TOWNSHIP OF BRICK** in a lawful manner. Please be advised that this Project is being funded through **TOWNSHIP OF BRICK**. By virtue of Executive Order #34 (1976), vendors currently suspended, debarred or disqualified are excluded from participating on this Project.

The successful Bidder shall be required to comply with the applicable statutory requirements of the Contract Documents and Plans which include all of the following: (i) *N.J.A.C. 17:27*; (ii) *N.J.S.A. 10:5-31 et seq.*; (iii) *Business Registrations (N.J.S.A. 52:32-44)*; (iv) *Prevailing Wage Act (N.J.S.A. 34:11-56.25, et seq.)*; (v) *Public Works Contractor Registration (N.J.S.A. 34:11-56.48)*; and any other legal requirements applicable to this Project.

The **TOWNSHIP OF BRICK** intends to award this Project to the lowest responsible and responsive Bidder in accordance with applicable law. **TOWNSHIP OF BRICK** reserves the right to reject any and all Bid Packets to the extent permitted by law. An award will be made, or Bid Packets will be rejected within sixty (60) Calendar Days after the opening of the Bid Packets, during which time the Bid Packets shall be irrevocable and unavailable to withdraw by Bidders, unless otherwise extended in the Contract Documents.
