

INVITATION TO BID

NOTICE TO BIDDERS is hereby given that Bids are invited and will be received as set forth below.

1. **OWNER:** Township of Brick
2. **WORK TITLE:** Brick Township Dredging and Marsh Restoration
3. **WORK SITE:** Brick Township, NJ
4. **WORK DESCRIPTION:** Year one of a two-year hydraulic dredging operation in Brick Township with placement of material in “Brick Area A” for restoration purposes.
